GENERAL VOLUNTEER AGREEMENT, WAIVER, AND RELEASE FORM

EVENT AND/OR PROJECT: _____

The undersigned voluntarily wishes to participate in a Mendocino County Fire Safe Council (“MCFSC”) sponsored event on the day of _____(date of event), which may be a hazardous activity with the potential for death, serious injury, and property loss. The risks include but are not limited to; those caused by terrain, facilities, temperature, weather, condition of equipment, vehicular traffic, negligent and non-negligent action of other people including, but not limited to participants, volunteers, officers, and citizens. I hereby assume all of the risks of participating in the Event. I certify that I am physically able to participate in the Event on the day of _____(date of event) and have not been advised otherwise by a qualified medical person.

GENERAL AGREEMENT, WAIVER, AND RELEASE (Adults over 18)

In consideration for being permitted by MCFSC to participate in the above activity, I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which I may have, or which may hereafter accrue, as a result, of my participation in said activity. This release is intended to discharge, in advance, MCFSC or the Mendocino County Resource Conservation District (MCRCD), including any of its officers, employees, agents and partners, from and against any and all liability arising out of or connected in any way with my participation in said activity, even though that liability may arise out of negligence or carelessness on the part of MCFSC (its officers, employees, agents or partners).

Knowing the risks involved, nevertheless, I have voluntarily chose to participate in said activity, and I hereby agree to assume any and all risks of injury or death and to release and hold harmless the MCFSC or the MCRCD (its officers, employees, agents and partners) who through negligence, carelessness, or any other act or omission might otherwise be liable to me. I further understand and agree that this waiver, release, and assumption of risks are to be binding on my heirs and assigns.

I further agree to indemnify and to hold MCFSC or MCRCD (its officers, employees, agents and partners) free and harmless from any loss, liability, damage, cost, or expense, which they may incur as a result, of any injury and/or property damage that I may sustain while participating in said activity.

I HAVE CAREFULLY READ THIS AGREEMENT, WAIVER, AND RELEASE AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MYSELF AND THE MENDOCINO COUNTY FIRE SAFE COUNCIL OR THE MENDOCINO COUNTY RESOURCE CONSERVATION DISTRICT AND I SIGN IT OF MY OWN FREE WILL.
